## **North Curl Curl Surf Life Saving Club Board Hire/Loan Agreement 2010/2011**

Registered club members who have achieved the performance criteria, as set out below, in the previous Nipper season may apply to the North Curl Curl Surf Life Saving Club Board Committee for the hire/loan of one of the club's boards for the current Nippers season.

### **1. Performance criteria**

1.1. The determination of the application will be at the discretion of the Committee but will be considered based on the following performance criteria:

- registered club members in the U/10 to U/14 age groups who have completed and passed the water proficiency test
- attendance records at Nipper activities
- attendance at board training sessions
- attendance at carnivals
- last season carnival results, Club, Branch & State

1.2. After completion of the first carnival, the Committee will consider applications from U/9 club members based on the individuals:

- club and carnival performance
- attendance records at Nipper activities
- attendance at board training sessions

### **2. Terms**

2.1. The successful applicant

2.1.1. Must pay a non refundable fee of

- \$70 for the use of a fibre glass board & cover for the season
- \$50 for glass boards if you supply the cover.
- \$50 for the use of soft board for the season

2.1.2. Will have exclusive use of the nominated board (selected by the committee from the club's stock) for one season only.

2.1.3. Must use padded protective cover for the glass boards

2.1.4. Bring the board to all nipper, club & carnival days

2.1.5. Return the board to the club at the completion of the current season



### **3. Conditions of Use**

- 3.1. All boards remain the property of North Curl Curl Surf Life Saving Club
- 3.2. The boards must be maintained in good condition.
- 3.3. The club will only cover repairs to the board, when occurring in the normal course of club competition and club training.
- 3.4. You will be responsible for the cost of repairs to the board for damage caused outside the normal course of club competition and training.
- 3.5. In the event you lose the loan board you will be responsible for the full replacement cost.
- 3.6. It is recommended that boards not be strapped on top of each other nor should they be left inside the car for long periods.
- 3.7. A club member will relinquish the rights to their board allocation (automatically lose their equipment allocation):
  - 3.7.1. If the club member does not compete in 75% of club nominated board training sessions and surf carnivals including Branch and State titles.
  - 3.7.2. If the club member retires from competition.
  - 3.7.3. If a club member wilfully contributes to the destruction of the equipment.
  - 3.7.4. If the committee considers there to be improper use of the loan board.

### **4. Allocation of Board**

- 4.1. North Curl Curl Surf Life Saving Club will allocate a board from the club stock holding for use over the current season.
- 4.2. Board Management will select the board and allocate to the successful applicant
